Besides, NVR can be issued in favour of foreign spouse or child of any citizen having proof of Bangladeshi origin. Furthermore, any foreign investor having long-term investment in trade or industry in Bangladesh worth at least 5 (five) million US dollar is eligible to receive NVR.
